Divisions: All dressage tests will be ridden in the small arena. Starter Novice, Novice and Training Divisions will use US Eventing Association rules for time penalties over and under optimum time. Note: if you have any questions about your abilities at a given level, check with your DC.

Baby Novice: Competitors must be D1 or D2, and have not ridden in the Starter Novice or any higher division during the current or previous year. Dressage: **USAE 2003 Training Level Test 1**. Test may be read. Fence Heights: Solid & brush under 24". Cross Country: Distance: Approx. 1,000/1500 meters; Max # Obstacles: 8-12. Stadium: Distance: 400 meters; Max. # Obstacles: 6-10.

<u>Starter Novice:</u> The Competitor must be a D3. Dressage: <u>USAE 2003 Training Level Test 1.</u> Fence Heights: Solid: 2'6", brush 2'9". Cross Country Speed (will be timed) 325m/m; Distance: Approx. 1500 meters; Max. # Obstacles: 12-18. Stadium: Speed 300 m/m; Distance: 400-500 meters; Max # Obstacles: 8-12.

Novice: The Competitor may hold any rating from C1 through A, if they (horse and rider combination) have not competed in any Pony Club competition during the current or preceding year in the Training Level or higher division. Dressage: **USAE 2002 Novice Test D.** Fence Heights: Solid: 2'11", brush 3'3". Cross Country Speed (will be timed): 375 m/m; Distance: Approx. 2000 meters; Max. # Obstacles: 12-20. Stadium: Speed: 300 m/m; Distance: 400-500 meters; Max # Obstacles: 8-12.

<u>Training</u>: The Competitor may hold any rating from C1 through A. Dressage: <u>USAE 2002 Training Test D.</u> Fence Heights: Solid: 3"3", brush 3'11". Cross Country Speed (will be timed): 425 m/m; Distance: Approx. 2500 meters; Max. # Obstacles: 16-22. Stadium: Speed: 325 m/m; Distance: 400-500 meters; Max. # Obstacles: 10-12.

- 2. Negative Coggins within twelve months must accompany entry. Horse name on entry form must match name on coggins.
- 3. Entry fee \$35.00. Make checks payable to Marlborough Pony Club. Lost piney fee \$10.00. Refunds before March 21st minus \$5.00. No Refunds after March 22nd.
- 4. Entries accepted based on postmark date. Organizers reserve the right to cancel or divide divisions as necessary.
- 5. Jump Judges: Parents and friends, we will need your help in this area. Bring lawn chairs, drinks, rainwear, insect repellent, and a sense of humor. Volunteer name(s) MUST accompany Entry Form. Instructions will be provided to Jump Judges on the day of the competition. Jump Judge

- 6. The Dressage tests will be available on either the MPC or Maryland Regional Web Site.
- 7. The Officials, MPC, DNR, Rosaryville State Park, MHT or the Rosaryville Conservancy herein described as "The Management", are not liable for any injury to person or horse at any time, which includes going to, coming from, and inside any ring. Neither will The Management be responsible for any vehicles, or any articles that may be lost or damaged. All owners and exhibitors will be held responsible for any damage incurred by them or their agents to properties on the event grounds.
- 8. Competitors may not ride more than one mount. The use of a whip or crop in the dressage phase is strictly forbidden and shall result in the competitor being eliminated. **NO EXCEPTIONS**. Pony Clubbers under the age of 8 as of January 1, 2003 are forbidden by the Regional Policies from participating in any jumping phases.
- 9. This Round Robin will be run in accordance with USPC rules and specifications. Protective headgear may be checked. All riders must wear ASTM/SEI approved hard hat. Dress is according to Pony Club standards. If rider is not properly dressed for all phases, he/she will not be permitted to ride.
- 10. All dogs must be leashed.
- 11. There will be food on the grounds but PLEASE BRING YOUR OWN WATER for horses.
- 12. Overnight stabling is limited please call Diane Hickok at 301 952 8599 or 301 814 6472 for information.
- 13. Cross-country course open for walking 3 PM Saturday April 5th. Gates Open 7 AM day of event. Dressage starts at 8:00 AM. Event will be held RAIN or SHINE.
- 14. As a courtesy to our gracious hosts, please leave the grounds cleaner than you found. Bring muck buckets!!
- 15. Directions: From the North I-97 to MD Rte 3 South becomes U.S. Rte 301 South. From Upper Marlboro (intersection of Rte 301 and MD Rte 4) continue on Rte 301 South four miles. Turn right at Marleton Road West sign and small state park sign. From the South U. S. Route 301 approximately 7.5 miles from the Rte 5/Rte 301 split. Park is located a short distance north of the Heathermore Road intersection, on the left. Watch for small state park sign and sign for Marleton Road West. From I-95/Washington Beltway take MD Rte 4 east/south to U.S. Rte 301 South at Upper Marlboro and follow Rte 301 South four miles. Turn right at Marleton Road West sign and small state park sign.
